**Director District 1**

Starting at the intersection of US Hwy 2 and Aplets Way.  
Southerly on Aplets Way to Prospect St.  
East on Prospect St to North St.  
South on North St to E Pleasant Ave.  
East on E Pleasant Ave to Woodring St.  
South on Woodring St to Riverside Dr.  
South on Riverside Dr to Mission Ave.  
West on Mission Ave to Aplets Way.  
South on Aplets Way to S Division St.  
South on S Division St to Sunset Hwy.  
West on Sunset Hwy to Paton St.  
Southerly on Paton St to Pioneer Ave.  
Westerly on Pioneer Ave to Pioneer Dr.  
Westerly on Pioneer Dr to Brender Canyon Rd.  
Southwesterly on Brender Canyon Rd to Icicle Canal service road.  
North by northwest, southwest and northerly on the Icicle Canal service road to the school district boundary.  
Clockwise on the school district boundary to the western crossing of US Hwy 2.  
Easterly on US Hwy 2 to the point of the beginning.

**Director District 2**

Starting at the intersection of US Hwy 2 and Aplets Way.  
Southerly on Aplets Way to Prospect St.  
East on Prospect St to North St.  
South on North St to E Pleasant Ave.  
East on E Pleasant Ave to Woodring St.  
South on Woodring St to Riverside Dr.  
South on Riverside Dr to Mission Ave.  
East on Mission Ave to Blue Star Way.  
North on Blue Star Way to Mission Ave.  
Southeasterly on Mission Ave to Parkhill St.  
South on Parkhill St to E Parkhill St.  
East on E Parkhill St to S Douglas St.  
North on S Douglas St to Cottage Ave.  
East on Cottage Ave to the Wenatchee River.

Southeasterly downstream through the Wenatchee River to the school district boundary.  
Counter-clockwise on the school district boundary to the western crossing of US Hwy 2.  
Easterly on US Hwy 2 to the point of the beginning.

### **Director District 3**

Starting at the intersection of the Wenatchee River and Cottage Ave.  
West on Cottage Ave to S Douglas St.  
South on S Douglas St to E Parkhill St.  
West on E Parkhill St to Parkhill St.  
North on Parkhill St to Mission Ave.  
Northwesterly on Mission Ave to Blue Star Way.  
South on Blue Star Way to Mission Ave.  
Westerly on Mission Ave to Aplet Way.  
South on Aplet Way to S Division St.  
South on S Division St to Pioneer Ave.  
Westerly on Pioneer Ave to Mission Creek Rd.  
South on Mission Creek Rd to Binder Rd.  
West on Binder Rd to Mission Creek Rd.  
South on Mission Creek Rd to Forest Service Rd 7100.  
Southerly on Forest Service Rd 7100 to the school district boundary.  
Counter-clockwise on the school district boundary to the eastern crossing of the  
Wenatchee River.  
Northwesterly through the Wenatchee River upstream to the point of the beginning.

Starting at the intersection of Icicle Canal service road and Brender Canyon Rd in Section  
01, Township 23, Ranger 18E.  
Easterly on Brender Canyon Rd to Pioneer Dr.  
Easterly on Pioneer Dr to Pioneer Ave.  
East on Pioneer Ave to Paton St.  
North on Paton St to Sunset Hwy.  
Easterly on Sunset Hwy to S Division St.  
South on S Division St to Pioneer Ave.  
Westerly on Pioneer Ave to Mission Creek Rd.  
South on Mission Creek Rd to Binder Rd.  
West on Binder Rd to Mission Creek Rd.  
South on Mission Creek Rd to Forest Service Rd 7100.  
Southerly on Forest Service Rd 7100 to the school district boundary.  
Clockwise on the school district boundary to the Icicle Canal service road.  
Southerly, northeasterly, and south by southeast on the Icicle Canal service road to the  
point of the beginning.
