DIRECTOR DISTRICTS

One board member is elected from each of the four director districts with an additional member being elected at large, as approved by the educational service district organization committee. At the time of election, the director must reside within the district he/she represents. Each director district is to represent approximately one-fourth of the residents of the Cashmere School District. The precinct boundaries and the number of residents in each director district are approved by the Educational Service District Organization Committee and are described as follows:

DIRECTOR DISTRICT NO. 1

Starting at the intersection of US HWY 2 and N Division St. South on N Division St to the Wenatchee River southern dike, northern side of Riverside Park. Easterly on the dike road to the extension of Maple St. South on Maple St to Cottage Ave. Westerly on Cottage Ave to Woodring St. South on Woodring St to Mission Ave. Westerly on Mission Ave to N Division St. South on N Division St to Sunset Ave. Westerly on Sunset Ave to Patron St. South on Patron St to Angier Ave. West on Angier Ave to Chapel St. South on Chapel St to Pioneer Ave. West on Pioneer Ave to Brender Canyon Rd. Westerly on Brender Canyon Rd to farm access road/driveway near Icicle Creek. Meandering northwest on the driveway to the school district boundary. Clockwise on the school district boundary to the western crossing of US HWY 2. Easterly on US HWY 2 to the point of the beginning.

DIRECTOR DISTRICT NO. 2

Starting at the intersection of US HWY 2 and N Division St. South on N Division St to the Wenatchee River southern dike, northern side of Riverside Park. Easterly on the dike road to the extension of Maple St. South on Maple St to Cottage Ave. Westerly on Cottage Ave to Woodring St. South on Woodring St to Mission Ave. Easterly on Mission Ave to Vine St. North on Vine St to Mission Ave. Easterly on Mission Ave to Parkhill St. South on Parkhill St to E Parkhill St. East on E Parkhill St to S Douglas St. North on S Douglas St to Mission Ave. East on Mission Ave to Riverfront Dr. North on Riverfront Dr to Cotlets Way. East on Cotlets Way to the Wenatchee River. Southerly and southeasterly on the Wenatchee River to the school district boundary. Counter-clockwise on the school district boundary to the western crossing of US HWY 2. Easterly on US HWY 2 to the point of the beginning.

DIRECTOR DISTRICT #3

Starting at the intersection of NFDR 7100 and Mission Creek Rd. North on Mission Creek Rd to Binder Rd. East on Binder Rd to Mission Creek Rd. North on Mission Creek Rd to Pioneer Ave. East on Pioneer Ave to S Division St. North on S Division St to Mission Ave. Easterly on Mission Ave to Vine St. North on Vine St to Mission Ave. Easterly on Mission Ave to Parkhill St. South on Parkhill St to E Parkhill St. East on E Parkhill St to S Douglas St. North on S Douglas St to Mission Ave. East on Mission Ave to Riverfront Dr. North on Riverfront Dr to Cotlets Way. East on Cotlets Way to the Wenatchee River. Southerly and southeasterly on the Wenatchee River to

DIRECTOR DISTRICT #4

Starting at the intersection of NFDR 7100 and Mission Creek Rd. North on Mission Creek Rd to Binder Rd. East on Binder Rd to Mission Creek Rd. North on Mission Creek Rd to Pioneer Ave. East on Pioneer Ave to S Division St. North on S Division St to Sunset Ave. Westerly on Sunset Ave to Patron St. South on Patron St to Angier Ave. West on Angier Ave to Chapel St. South on Chapel St to Pioneer Ave. West on Pioneer Ave to Brender Canyon Rd. Westerly on Brender Canyon Rd to farm access road/driveway near Icicle Creek. Meandering northwest on the driveway to the school district boundary. Counter-clockwise on the school district boundary to the southern crossing of NFDR 7100. North on NFDR 7100 to the point of the beginning.

DIRECTOR DISTRICT #5

Director District #5 is an at-large position. The boundaries for Director District #5 are the same as the boundaries of the Cashmere School District No. 222.
