CALL TO ORDER:

Chairman Ted Snodgrass called the meeting to order at 7:00 AM.

DECLARATION OF QUORUM:

Board members Ted Snodgrass, Nicholas Wood and Aaron Bessonette were present. Board members Paul Nelson and Roger Perleberg were absent. There were two other present including Superintendent Johnson.

1.0 Flag Salute

1.1. Chairman Ted Snodgrass led the Pledge of Allegiance.

2.0 Approval of the Agenda – On a motion by Vice-Chairman Nicholas Wood, the Board approved the agenda as presented.

3.0 Reports, Correspondence and Program –

3.1. Board Report – There was no Board Report.

3.2. Superintendent's Report – There was no Superintendent's Report.

3.2.1. Ad / Hoc Safety Committee Update – Scott Brown who leads the Ad/ Hoc Safety Committee was present to review the attached “draft” [security recommendations](#) the committee recently identified throughout the district. The Ad / Hoc Safety Committee is made up of representatives from the community as well as representatives from each building. Mr. Brown also noted administrators would be participating in a “live scenario” tabletop activity on January 20th from 9AM-12PM at the high school. A tabletop exercise is a training tool that simulates emergency situations in an informal environment. The facilitator guides participants through a scenario where they are able to practice appropriate response strategies. Mr. Brown went on to add this activity will be a coordinated effort with local law enforcement and will not involve students. Mr. Brown restated that these recommendations are “preliminary” and still very much a draft. He will work with the committee to finalize the recommendations and they will make a final presentation to the board at a later date.

3.2.2. Cashmere High School Activity Code – Vice Principal Scott Brown reviewed the attached draft document [CHS Activities Code](#) with the Board. This code was created to outline clear expectations for CHS activities participants. This document describes expectations, guidelines and procedures governing students who participate in the Cashmere Activities Program such as band, drama, clubs, etc. and is similar to the CHS Athletic Code. Mr. Brown explained this code would apply to all competitive and performing activities.

- 3.2.3. Board Policy 1210 – Annual Organizational Meeting / Election of Officers – Review – Superintendent Johnson reminded the Board this process would be coming up for the December regular board meeting.

- 3.2.4. Board Policy / Procedure 3210 – Nondiscrimination – Review – Superintendent Johnson reviewed Policy / Procedure 3210 – Nondiscrimination with the Board.

- 3.2.5. Schedule Open Government Training – Michelle Price, NCESD – Superintendent Johnson stated Superintendent Michelle Price from the NCESD would be present for the December regular board meeting to provide an Open Government Training. This training is a requirement for every school director.
